Recombinant Human IL-15 is an immunomodulating cytokine that stimulates the proliferation of T lymphocytes. It is also essential in the development, survival and activation of NK cells. Recombinant human IL-15 is a single, non-glycosylated polypeptide chain containing 114 amino acids and having a molecular mass of 13.2kDa.
